- **Bermuda Update - new online filing system.** The Bermuda Monetary Authority is currently rolling out a new secure online registration and filing system known as INTEGRA™ which will replace the existing Corporate Registration Processing system.
- **Quarterly Fintech Regulatory Update.** Since June, there have been some important changes to fintech related legal and regulatory frameworks in Bermuda, the Cayman Islands & BVI.
- **Bank of Asia (BVI) - a digital cross-border bank.** Bank of Asia is a digital cross-border bank licensed in the BVI and officially launched on 19 July 2018 to address the needs of offshore companies and their owners.
- **Appointment of AML Officers in the Cayman Islands.** The Cayman Islands Monetary Authority recently issued clarification of its Guidance Notes in respect of the Anti-Money Laundering Regulations to make it clear that all funds are required to appoint AML officers before 31 December 2018.
- **BVI Update - New Visa Exemption Order for Chinese Nationals.** In recognition of the significant numbers of BVI companies being used as structures for investments into or originating from mainland China, the BVI government recently enacted legislative measures which have made it easier for Chinese individuals to visit the BVI.
- **Bermuda RSC amended to require leave to bring derivative actions.** From 9 July 2018, derivative actions commenced in Bermuda may not be continued without leave from the Supreme Court.
