

Bermuda, Guernsey and Isle of Man purpose trusts, Cayman Islands STAR trusts and British Virgin Islands VISTA trusts are now increasingly being used as part of sophisticated international planning exercises.

We have also seen an increased use of trusts by the insurance industry, for example, to hold insurance policies, annuities or other related insurance products.
