

### ALLIED GROUP

Assisted Allied Group on the closing of Allied Merger Corporation (AMC)'s private placement financing for aggregate gross proceeds of approximately USD267 million (Financing) as well as the execution of a business combination agreement with Allied Gold Corp Limited (AGCL) and Mondavi Ventures Ltd (Mondavi) (Business Combination Agreement) in connection with a previous business combination and reverse take-over transaction (Transaction).
