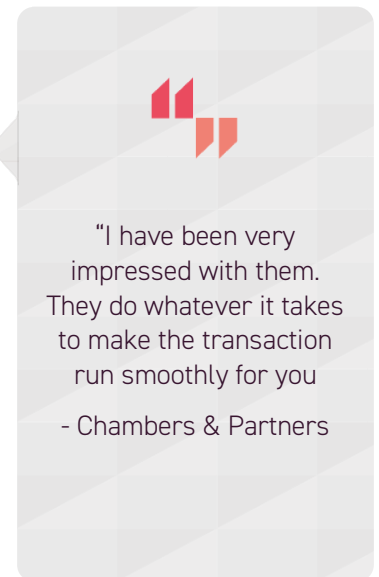
Our listing sponsor services include:

- Responding quickly to all enquiries made by the stock exchange on behalf of the issuer
