Maritime transportation is inextricably linked, if not dependent, upon marine insurance. Marine incidents and accidents unfortunately happen, with varying degrees of seriousness, with vessels, crew and cargo being at risk.

Marine insurance is an area of the law which requires specialised knowledge of both the applicable marine insurance principles and limitation of liability Conventions, as well as the technicality of ships and shipping and port operations.

#### 1. ACTING AS LEGAL CORRESPONDENT FOR P&I CLUBS AND HULL AND MACHINERY UNDERWRITERS

Correspondents act as independent advisers on behalf of P & I Club Members and are available to provide direct and immediate assistance in the event of an incident or casualty involving a vessel entered with the Club. The appointed correspondent may represent either ship owners', charterers' or cargo owners' interests, depending on the insurance policy cover.

While general P&I correspondents are mainly shipping agents, providing basic assistance and coordination services to P&I clubs, legal correspondents play a crucial role in protecting the interests of P&I Clubs and marine underwriters, in view of the specialised knowledge that the principles of marine insurance call for.
