Our Private Client lawyers also work closely with our Dispute Resolution lawyers in matters involving trust disputes and have been involved in most of the major trust-related cases in the Crown Dependencies including, in Jersey, the innovative Z Trusts cases relating to insolvent trusts and the landmark decision that a settlor's exercise of personal powers of revocation of a trust should be declared invalid; in Guernsey, the first reported Hasting Bass decision and in the Isle of Man the first reported case on the extent of a former trustee's rights to an indemnity from the trust fund.

REPRESENTATIVE WORK

ASSET PROTECTION TRUST STRUCTURE

We advised the trustees in the establishment of a Middle East family's private trust company structure containing multiple trusts for asset protection, investment, lifestyle and wealth succession planning of the family's business (valued at USD9 billion) and personal assets, the trusts containing provisions for prescribed directions, reserved powers, different sub-funds for investment and distinct asset holding purposes to balance control between the professional trustee and family members..

OFF-BALANCE SHEET DEBT STRUCTURING

We advised and prepared the necessary trust documentation in relation to a failed investment of over GBP125 million into an engineering company and its subsidiaries. Our client, together with two commercial banks invested in the group companies which went into liquidation and our client wished to move their share ownership in, and their mezzanine debt financing to the group companies, to an off-balance sheet structure. That structure was a purpose trust with private trust company acting as trustee. Our role was to advise on trusts law, to prepare the necessary documentation for the structure and to negotiate the indemnification protection with the trustee.

SETTLOR DIRECTED TRUSTS

We established a new family office for a Middle Eastern family utilising a private trust company structure with settlor direction and reserved powers. The structure involved four levels, each level containing largely bespoke workings to build-in controls for the family and how the family interacts with itself and its trustee. We prepared all necessary documentation for this structure including the private trust company documents, the underlying trust instruments, the underlying SPV articles of association and related minutes.

INSOLVENT TRUSTS

In the first proceedings of its kind in any trust law jurisdiction with ramifications for all such jurisdictions, Appleby acted for a Jersey trustee in court proceedings relating to its administration of an insolvent trust structure resulting in a number of significant decisions relating to the existence of a trustee's equitable lien over trust assets, the role of a trustee and the Court in administering an insolvent trust structure and the retirement of trustees in the context of an insolvent trust.

FOUNDATIONS

We advised a foundation with family business assets valued at over USD1 billion and a family net worth of over USD6 billion where the founder wished the next generation to lead the family business but ensuring a structured interaction between the foundation and family members.

DATA TRUST

Appleby advised on the establishment of the first ever "data trust" under Jersey law, through a pilot project called "LifeCycle" led by Digital Jersey as parts of its strategy to position Jersey as a leading jurisdiction for data stewardship. The concept involves the innovative use of a trust structure to hold personal data so it can be stored, managed and shared safely, lawfully, in accordance with the trust parameters and applying fiduciary duties to the stewardship of data within a highly regulated environment.
