

UNICORN LITIGATION

Appleby act in ongoing proceedings in the Isle of Man seeking to recover in excess of GBP60 million transferred from group companies in alleged breach of directors' duties against former directors to BVI and Isle of Man companies and successfully opposed jurisdictional challenges mounted on multiple grounds by the defendants to claims. In addition, Appleby act for the same parties as Defendants to proceedings issued by one of the Defendants as to the breach of duty seeking declaratory relief in respect of a trust purportedly declared over all of one of the defendant's assets. Appleby is instructed to represent RBSI in relation to a very high value claim taken against the bank. We successfully struck out the claim on appeal to the Staff of Government Division. This landmark judgment affirmed for the first time in the Isle of Man that, in the absence of fraud or an assumption of responsibility, a Bank does not owe duties to a third party non-customer following the principles set out in Royal Brunei v Tan. The matter has now been heard by the Privy Council and Judgment is awaited.
